## LIHEAP

It is that time of year again. The Low Income Home Energy Assistance Program (LIHEAP) can help you in two ways: Energy Assistance/ Regular Heating (EA) and Energy Crisis Intervention Program (ECIP).

Energy Assistance (EA) helps you with a onetime payment for your primary heating bills from November through March.

The Energy Crisis Intervention Program (ECIP) helps pay your fuel bill when your energy is shut off or is threatened to be shut off. The amount of help you receive is based on the amount of money needed to settle your crisis with the energy provider.

The ECIP is available during the following months:

- Winter ECIP is available November through May based on funding; the maximum amount you could receive is \$800
- Summer ECIP is available June through September based on funding; the maximum amount you could receive is \$300

## What is *Olmstead*?

The US Supreme Court held that public entities (state and local government) have an affirmative obligation under the **Americans with Disabilities Act (ADA)** to ensure that individuals with disabilities live in the least restrictive, most integrated settings as possible, provided the setting is appropriate for the individual. The Olmstead decision was handed down in 1999 in which the Supreme Court construed that the ADA requires states to place qualified individuals with mental disabilities in community settings rather than institutions. Four young people in Camden County were recently found to be qualified as our clients and are living in nursing homes. Steps are being taken to change their living conditions ac-

cordingly. Now we wonder how many other potential clients we might have helped had we known about their situation.
